TERMS

- 1. Students will be assessed a fee of \$55.00 for in district and out of district students. Checks or cash must accompany the application form to be considered for the class. - 2. Students must complete all assignments and pass the final test with 70% proficiency. Student is allowed to retake the test two times.
